#1 - Approval of Minutes and Financial Statements

#3 – Resolution – To Call for a Referendum of the Qualified Voters of Morgan County, Tennessee and in Accordance with TCA 57-4-103, Permitting nad Legalizing the Sale of Liquor -By-The-Drink within Morgan County, Tennessee Commissioner Anderson made a motion to approve the aforementioned Resolution, Commissioner Walls seconded. Commissioner Anderson explained a little about the Resolution and a small amendment that was made to correct a TCA code. Commissioner Justes asked who or what committee would be over the approval of sites for liquor by the drink. Commissioner Justes stated he did not think it would be the Beer Board. Commissioner Lindsay asked what law enforcement thought was on this situation.

#4 - Resolution - Authorizing Morgan County to Join the State of Tennessee and other Local Governments in Amending the Tennessee State-Subdivision Opioid Abatement Agreement and Approving the Related Settlemen Agreement

Commissioner Roberts made a motion to approve the aforementioned Resolution pertaining to the opioid abatement program, Commissioner Plank seconded

Motion passed unanimously. (18/0)

#5 - Resolution - Tax Levy for Fiscal Year 2024-25

Commissioner Roberts made a motion to approve the Tax Levy Resolution for Fiscal Year 2024-25, Commissioner Jackson seconded. Executive Langley stated that there was no tax increase this year.

Motion passed unanimously. (18/0)

#6 – Resolution – Making Appropriations for the Various Funds, Departments, Institutions, Offices and Agencies for Fiscal Year 2024-25

Commissioner Roberts made a motion to approve the Appropriations Resolution for Fiscal Year 2024-25, Commissioner Jackson seconded. Commissioner Roberts state that there is a 3% raise for the employees.

Motion passed unanimously. (18/0)

#7 - Motion to Approve the Additional Employee in Sanitation Dept.

Commissioner Roberts made a motion to approve the additional employee in the Sanitation Dept, commissioner Kennedy seconded. Executive Langley stated that this was for safety at the transfer station.

Motion passed unanimously. (18/0)

#8 - Proclamation - Declaring July Standing with Sheriff Wayne Potter Month

Commissioner Roberts made a motion to approve the Proclamation, Commissioner Justes seconded. Sheriff Potter spoke and gave an update on his health. He also asked the commissioners that if he we not be able to run in the next election if they would consider Rick Hamby as his appointed fill in.

Motion passed unanimously. (18/0)

#9 - Motion - Approve Amendment to Inmate Heath Services Agreement

Commissioner Roberts made a motion to approve the amendment to the Inmate Heath Services Agreement, Commissioner Justes seconded. Commissioner Roberts stated that a few words have changed but the actual price has decreased.

Motion passed unanimously. (18/0)

#10 - Motion to Approve TDEC Grant - Convenience Center

Commissioner Kennedy made a motion to approve the application for TDEC Grant for Convenience Centers in Oakdale, Coalfield, Sunbright, Genesis Road and Wartburg,

Commissioner Jackson seconded. This grant is \$122,581.63 which the county will be responsible for 10% which would be \$12,258.00

Motion passed unanimously. (18/0)

Executive Langley stated that the county will be applying for the used oil grant in the amount of \$87,000.00 for paving at the Sunbright & Oakdale convenience centers. There is no match for this grant.

#11 - Motion - Budget Amendment 122-3 - Drug Fund

Commissioner Roberts made a motion to approve budget amendment 122-3 for Drug Fund in the amount of \$15,000.00, Commissioner Justes seconded. Year End Budget Amendments.

#12 - Motion - Budget Amendment 131-7 - Highway Department

Commissioner Roberts made a motion to approve budget amendment 131-7 for Highway Dept. in the amount of \$2,383,907.16, Commissioner Kries seconded. Year End Budget Amendments.

Motion passed unanimously. (18/0)

#13 – Motion – Approval of Surplus of Dodge Van from Courthouse Maintenance Commissioner Roberts made a motion to approve the surplus of Van from Courthouse Maintenance, Commissioner Justes seconded.

Motion passed unanimously. (18/0)

#14 - Motion - Budget Amendments #95 - #117 BOE

Commissioner Roberts made a motion to approve the aforementioned budget amendments for Board of Education, Commissioner Henessee seconded.

Motion passed unanimously. (18/0)

Building Committee

Commissioner Morgan stated that a building committee meeting was held and they are pricing the staining or painting of the Courthouse and also the pressure washing or steam cleaning. The pricing for stain is approximately \$4,500.00. The paving will be completed at a cost of \$71,000.00 on July 8th. The windows in the ETHRA building have been purchased and installed and the county has been reimbursed by ETHRA.

Audit Committee

Chairman Melissa Kries of the Audit Committee presented the observations and recommendations of Fiscal Year 2023

- The school's federal projects fund was over drafted for three months leading to the Trustee writing checks in excess of the bank account balances
- 2. Payroll liabilities accounts were not reconciled with related payroll reports in a timely manner
- 3. Disbursements amounting to \$102,725.00 were provided to each school's activity account based on the number of students enrolled at each school to be used to purchase furniture. This distributions were not legal.

The Audit Committee concurred with the auditors recommendations of timely reimbursements, monthly reconciliations, and purchasing policy.
