#7 - Motion - Budget Amendment 101-4 - Ambulance/EMS

Commissioner Roberts made a motion to approve budget amendment 101-4 for Ambulance/EMS in the amount of \$8,415.00, Commissioner Kennedy seconded. For garage door openers.

#8 - Motion - Budget Amendment 101-5 - Ambulance/EMS
